

## Broken walls – Oct 7, 2014 rev 1.1

There is only 1 law that should be in existence in this country - not 2, 3 or more.

KJV Exodus 12:49 **One law** shall be to him that is **homeborn, and** unto the **stranger** that sojourneth among you.



What are the other laws?

**#1** There is a law to the people of the land like all the laws that US citizens must follow

**#2** The politicians write the laws but exempt themselves from it (ie Obama Care...) & do not have to follow all the laws of #1

**#3** The powers, ruling elites, behind the politicians are exempt from almost all laws (or can get around it)

**#4** Corporations can violate laws and get a hand slap but a Citizen will get the entire weight of the law thrown on them.

**#5** The (illegal) aliens among us are immune to #1 ie:

The Liberian Ebola patient in Dallas is a clear example of this hypocrisy. The Dallas DA is looking into bringing charges against Thomas Duncan who fled Liberian with Ebola. The charges? Knowingly spreading the deadly virus on the public. According to the District Attorney this is considered **AGGREGATED ASSAULT.**

Dallas County District Attorney Craig Watkins is **exploring potential criminal charges against Dallas Ebola patient** Thomas Eric Duncan.

A spokeswoman for the DA's office said in a statement the office is investigating whether Duncan **“knowingly and intentionally exposed the public to a deadly virus - making this a criminal matter.”**

The office said it would be **“irresponsible” if they didn't explore charges,** but they are treading lightly because they cannot place an Ebola patient into the county jail and expose others.

The spokeswoman said it would be **“cruel and inhumane to go after a person on their death bed,”** but the DA's office wants to show **“there are consequences to entering the country by falsifying documents and then knowingly putting the public at risk.”**

The office said it **has prosecuted defendants** who are **HIV positive and intentionally have sex with others with no protection. Those people have been charged with aggravated assault** and the office is exploring if the same charge could apply to Duncan.

KJV Leviticus 13:4-6

4 If the bright spot be white in the skin of his flesh, and in sight be not deeper than the skin, and the hair thereof be not turned white; then the priest shall **shut up him that hath the plague seven days:**

5 And the priest shall look on him the seventh day: and, behold, if the plague in his sight be at a stay, and the plague spread not in the skin; then the priest shall **shut him up seven days more:**

6 And the priest **shall look on him again the seventh day:** and, behold, if the plague be somewhat dark, and the plague spread not in the skin, the priest shall pronounce him clean: it is but a scab: and he shall wash his clothes, and be clean.

The law of Leprosy mandates removing the plague person out of the healthy population - Lev 13:46

KJV Leviticus 13:46 **All the days wherein the plague shall be in him he shall be defiled; he is unclean: he shall dwell alone; without the camp shall his habitation be.**

The law of Leprosy mandates that the clothing be burnt (something which is being done with the Ebola clothing, sheets, bedding,....) - Lev13:52

KJV Leviticus 13:52 **He shall therefore burn that garment,** whether warp or woof, in woollen or in linen, or any thing of skin, wherein the plague is: for it is a fretting leprosy; it shall be **burnt in the fire.**

The law of Leprosy mandates that the house, if it can't be cleansed, be torn down and all the material dumped in an unclean place.

KJV Leviticus 14:44-45

44 Then the priest shall come and look, and, behold, **if the plague be spread in the house,** it is a fretting leprosy in the house; it is unclean.

45 And he **shall break down the house,** the stones of it, and the timber thereof, and all the mortar of the house; and he shall **carry them forth out of the city into an unclean place.**

2 Laws willfully being violated in Texas that is being totally ignored by the Dallas DA:

1) Not prosecuting the Federal officials (including President Obama and all his cabinet officials) of **"knowingly and intentionally exposed the public to a deadly virus"**. This is according to the Dallas DA a **"Criminal matter"**.

2) Not quarantining the sick persons out of the healthy population (Their home countries are an excellent quarantining place).

Other laws were violated but the Dallas DA is ignoring the biblical law of all the plague filled illegal aliens and focusing on a near dead alien who came in with a tourist visa.
