

## Don't open that door – Halloween warning - Sept 27, 2015



This is the fourth year [2011](#) [2013](#) [2014](#) that a warning will be sent to Christians not to engage in any Halloween activities.

Quoting bible verses which speaks against Halloween has proven to be unfruitful but everyone loves a good story. Two recent news stories show the dangers of Halloween.

Why are Christians not worried about the occult references in Halloween?

Maybe because 6 out of 10 Christians in a 2008 telephone survey didn't believe Satan is real but just a symbol of evil.

Nearly six out of ten Christians either strongly agreed or somewhat agreed with the statement that Satan "is not a living being but is a symbol of evil," the survey found.

Hank Hanegraaff, "Widely regarded as one of the world's leading Christian authors and apologists," answers the Question "Can a Christian be demon-possessed?" His answer "*Absolutely not... no Christian can be 'demon-possessed'*"

A Christian won't have any fear about any occultism tied to Halloween if Christians believe that Satan is only a symbol for evil or once you become a Christian then you are safe from any demonic attack.

The news articles demonstrate demonic activity in modern day life and that those being tormented are left to fend for themselves without proper support from churches.



The first news article is from Indystar.com, an e-newspaper covering the Indianapolis Indiana area. It reports the demonic activity at a house in Gary Indiana from November 2011 to January 2013. These events revolving around 5 persons: Latoya Ammons, her 2 boys ages 7 and 9 & 12 year old daughter age along with Ammon's mother, Rosa Campbell.

There are over 800 pages of documentation from the hospital, police, psychologist, church and Child Protective services records.

Before starting. The purpose of what follows is not to create fear by showing the power of Satan but the power and authority that Christians have against Satan when Christians are walking uprightly before God. It's a power that Satan cannot defeat and it's a power that the churches are not teaching. This is the purpose why the [miracles of Jesus](#) and the [Apostles](#) had to be reviewed prior to this study to demonstrate the power we have as Christians.

Ammon and family moved into the rental house in Nov 2011 and in December big horseflies began showing up in their screened in porch. They killed them and killed them and killed them but they kept returning.

After midnight they began hearing clumping footsteps up the basement stairs and the creak of the door – no one was there and the noise continued even after locking the door.

The grandmother woke up seeing a shadowy figure pacing the living room and when investigated found large wet footprints.

In March 2012, evil ramped up in the house, at around 2am the 12 year daughter was levitating above the bed.

Praise Jesus that the mother and several others surrounded the girl and began praying and the girl lowered to the bed.

Both the grandmother and mother were freaking out. The grandmother told her daughter “We need help. We need to talk to someone who knows how to deal with it.”

Put yourself in their shoes. They had these events going on at their house:

- 1) endless amount of horseflies showing up,
- 2) clumping sounds on the basement stairs,
- 3) creaking opening of the basement door,
- 4) pacing man figures leaving wet footprints in the living room and now
- 5) your child is levitating above her bed.


Obviously you find yourself a church that can handle the situation. The article said:

“They called the local churches, but most refused to listen.”

**ABANDONED BY THE CHURCH**

Let this sink in Christians. When a family was in their greatest need in their life for both spiritual and physical salvation then they were abandoned by the churches.

Below are the churches (red dots) in the area around their house on Carolina St (yellow circle). I wonder how many of these churches turned her down.



The “churches” that responded gave bad advice such as:

*“officials at one church ... recommended the family clean the home with bleach and ammonia, then use oil to draw crosses on every door and window.”*

If the church priest and pastors won’t help then you seek help in the occult which they did.

*“They reached out to two clairvoyants, who said the family’s home was besieged by more than 200 demons.”*

Ammon followed the clairvoyant's advice. What was that advice? That they should:

made an altar in the basement.

Ammons covered an end table with a white sheet, then placed a white candle and statue of Mary, Joseph and Jesus on it. She opened a Bible to Psalm 91.

*She said she and another person donned white T-shirts and wound white scarves around their heads.*

*Also on a clairvoyant's advice, they burned sage and sulfur throughout the house, starting upstairs and working their way down. The smoke was so thick they could hardly breathe.*

*Ammons drew a cross with the smoke.*

Bad advice. Picture yourself as the apostle Peter sitting by the fire with Jesus after His resurrection.

**Jesus (calling Peter):** Hey Peter, come over here.

**Peter:** Yes Lord

**Jesus:** I'll give you the technique on how to expel demons after I leave.

**Peter (taking notes):** Yes Lord, speak

**Jesus:** I want you to clean the house with bleach and ammonia, set up a table with a candle and make an idol of me as a baby before I receive the power and authority of the Holy Spirit when I was baptized. Next make idols of my mother and father and place them next to my idol. Now get some salt and pour it around the altar and burn sage around the person and in the house.



Did that happen in the bible? No. Jesus told the apostles to lay their hands on people, pray for them, anoint them, fast and command the demons out of them.

What happened to the Ammon family after the altar?

*“nothing odd happened for three days. **Then, things got worse.**”*

Does that not show you that idols won't save you – only following the word of God as stated in the bible will you find salvation from Satan – which the Ammon family will find out after going thru the school of hard knocks.

How much worse did events escalate?

*“The kids' eyes bulged, evil smiles crossed their faces and their voices deepened every time.”*

*The youngest boy, then 7, sat in a closet talking to a boy that no one else could see. The other boy was describing what it felt like to be killed.*

*[the grandmother] said the 7-year-old once flew out of the bathroom as if he'd been thrown*

The family went to their family physician, Dr. Geoffrey Onyeukwu, for help on April 19, 2012.

Dr Onyeukwu evaluated the family and his assessment were that they suffered:



"delusions of ghost in home"  
"hallucinations."  
"history of ghost at home"

The grandmother said her grandsons then:

*cursed Onyeukwu in demonic voices, raging at him.*

*Medical staff said the youngest boy was "lifted and thrown into the wall with nobody touching him," according to a DCS report.*

*The boys abruptly passed out and wouldn't come to*

911 was called and 7 to 8 police officers showed up along with multiple ambulances. Ammon was getting to her lowest point because she tried to anoint her boys with oil and the response from the concerned hospital staff:

***hospital personnel laughed at her desire to anoint her sons in olive oil.***



Ammon couldn't rely on the churches, the psychics or the doctors for help. Where could she stand on? Ammon stated:

***"I couldn't talk to them," she said, "so I talked to God."***

That was a powerful statement. Her faith in Jesus was growing stronger because of her trials and tribulations. You will either grow stronger or crumble in these situations – she was strengthening.

The boys woke up in the hospital then the 7 year old:

*screamed and thrashed...[and] it took five men to hold him down.*

Remember the 2 men demonized by the legion of demons that demonstrated strength that no one could bind them – Mk5:2-4

RSV Mark 5:2-4

2 And when he had come out of the boat, there met him out of the tombs a man with an unclean spirit,

3 who lived among the tombs; and no one could bind him any more, even with a chain;

4 for he had often been bound with fetters and chains, but the chains he wrenched apart, and the fetters he broke in pieces; and no one had the strength to subdue him.



At this time an anonymous caller tipped off DCS that Ammon might be abusing her children. DCS family case manager Valerie Washington shows up at the hospital and asks the hospital personal to examine them and reports that they were:

*healthy and free of marks or bruises. A hospital psychiatrist evaluated Ammons and determined she was of "sound mind."*

Valerie Washington was interviewing the family and the manifestations began to happen:

*7-year-old boy started growling with his teeth showing. His eyes rolled back in his head.*

*The boy locked his hands around his older brother's throat and refused to let go until adults pried his hands open.*

Later in the evening Washington, the grandmother, both boys and a registered nurse, Willie Lee Walker, go into a small exam room for an interview. The youngest boy then began to manifest the demon by saying:

*"It's time to die," the boy said in a deep, unnatural voice. "I will kill you."  
While the youngest boy spoke, the older brother started head-butting Campbell [the grandmother] in the stomach.*

***Campbell grabbed her grandson's hands and started praying.***

*According to Washington's original DCS report — an account corroborated by Walker, the nurse — the 9-year-old had a "weird grin" and **walked backward up a wall to the ceiling. He then flipped over Campbell, landing on his feet.** He never let go of his grandmother's hand.*

Both Washington and Walker freak out and flee out of the room.

*A police report quoted Washington saying she believed there could be an "evil influence" affecting the family.*

*DCS took the emergency step of taking custody of the children without a court order.*

*"All of the children were experiencing (sic) spiritual and emotional distress," Washington wrote in the DCS form.*

*Ammons told The Star she and her children cried because they didn't want to be separated.*

*"We'd already been through so much and fought so hard for our lives," she recalled. **"It was obvious we were a team, and we were beating it"** — whatever we were fighting. We made it through together as a team, and they separated us."*



Divide and Conquer is a technique used to defeat a superior enemy and this is what Satan now rolls out. Maybe Satan felt that the family wasn't breaking as expected and that their faith and belief was growing to a point that he would be defeated. Ammon was feeling victory was around the corner so Satan's servants come in and divide the family – I suppose hoping to weaken the united family strength.



One positive thing happened in the hospital. The hospital chaplain contacts Rev. Michael Maginot, a Catholic priest in Merrillville (town south of Gary).

*the chaplain asked him to perform an exorcism on Ammons' 9-year-old son.*

Why didn't the hospital chaplain gather some believers together and cast out the demons? The Protestant and Catholic seminaries are not teaching new preachers/priest how to fight against demons.

RSV Mark 16:17 And **these signs will accompany those who believe: in my name they will cast out demons;** they will speak in new tongues;

RSV Ephesians 6:12 For we are not contending against flesh and blood, but against the principalities, against the powers, against the world rulers of this present darkness, **against the spiritual hosts of wickedness in the heavenly places.**

Rev Maginot interviews Ammon in her house for 4 hours. During this interview Rev Maginot witnessed:

1) "flickering bathroom light" that would stop when he walked over to it

- 2) "Venetian blinds in the kitchen swinging even though there was no air current"
- 3) "saw wet footprints throughout the living room"
- 4) Ammon "convulsed when he placed a crucifix against her head."

*Maginot said he was convinced the family was being tormented by demons. He said he also believed there were ghosts in the house.*

*Maginot blessed the house before he left — praying, reading from the Bible and sprinkling holy water in each room.*

*He told Ammons and Campbell to leave because it wasn't safe.*

A week later Ammon, Campbell, 3 police officers, Rev Maginot and Washington (DCS family case manager) visited the house to check the condition of the home.

During the interview at the house:

- 1) "the officer's audio recorders malfunctioned" even though new batteries were loaded.
- 2) another audio recorder when he played it back later, heard an unknown voice whisper "hey,"
- 3) cloudy white and green images on photos looking like faces appeared.
- 4) The radio in his [Cpt Austin] police-issued Ford malfunctioned on the way home.
- 5) Cpt Austin's garage door wouldn't open
- 6) Cpt Austin's driver's seat in his personal 2005 Infiniti also started moving backward and forward on its own.



This is an important point. If you innocently visit a place or engage in an activity with demonic ties then demons at that location/event could attach themselves to you. Activities such as Halloween, reading Harry Potter books, watching a Horror movie with lots of death and blasphemy or, listening to Hard Rock music – just to name a few.

Psychologists were brought in to evaluate the family:

*Clinical psychologist Stacy Wright, who evaluated Ammons' youngest son, said the boy tended to act possessed when he was challenged, redirected or asked questions he didn't want to answer. In her evaluation, Wright wrote that he seemed coherent and logical except when he talked about demons.*

Here's a clue for discernment of unclean spirits by observation. Demonic manifestation may occur when demonized persons are asked to do things that they don't want to do. This is a pressure point that one can use to force a demon out.

Psychologist Wright evaluation:

***"This appears to be an unfortunate and sad case of a child who has been induced into a delusional system perpetuated by his mother and potentially reinforced" by other relatives, she wrote in her psychological evaluation.***



*Clinical psychologist Joel Schwartz, who evaluated Ammons' daughter and older son, came to a similar conclusion.*

*"There also appears to be a need to assess the extent to which (Ammons' daughter) may have been unduly influenced by her mother's concerns that the family was exposed to paranormal experiences," Schwartz wrote.*

*Ammons also was examined several times by psychologists, who said she was "guarded," but did not seem to be "experiencing symptoms of psychosis or thought disorder." One psychologist recommended Ammons be assessed to "determine whether her religiosity may be masking underlying delusional ideations or perceptual disturbances."*

*Ammons — and all three kids — continued to insist they were possessed by demons.*

*DCS set goals for the family. One of them stipulated that the children "not discuss demons and being possessed and ... take responsibility for their actions." They also needed to participate in therapy to address past behavior.*

*While DCS officials credited Ammons for sharing a "close bond" with her children, the agency also said she needed to use "alternate forms of discipline not directly related to religion and demon possession," according to DCS' case plan. Appropriate discipline included encouragement, rules and withholding privileges. She could work on those goals during supervised visits with the children.*

The psychologist offered no help, they used big words and laid the blame on the mom. The psychologist told them not to talk about the problem or rely on religion.

Meanwhile Rev Maginot:

**ABANDONED BY THE CHURCH**

*wrote a report detailing his findings and asked Bishop Dale Melczek's permission to perform an exorcism on Ammons.*

*Maginot said Melczek had never authorized an exorcism in 21 years as bishop of the Diocese of Gary.*

*The bishop told Maginot to contact other priests who have performed exorcisms.*

*Maginot said he needed other priests to give him the ritual for a minor exorcism, which does not require church approval. The priests he consulted told him to look it up on the Internet.*

You have a priest attempting to perform an exorcism on a clearly demonized family and the bishop says no. 1Peter5:8 states that "the devil prowls around like a roaring lion, seeking someone to devour." But not in Gary Indiana where Bishop Melczek apparently doesn't believe that the devil is prowling around.



Rev Maginot contacts the other exorcists and requests the procedure. They said to go look it up on the internet! Is it any wonder why the Catholic and Protestant churches are losing member with this type of attitude to a family being torn at by the devil? Praise to Rev Maginot for fighting for Ammon and family!

Rev Maginot finds the Exorcism procedure possibly the one Father Malachi Martin (former Jesuit & Catholic Exorcist for 30 years) has in his book "Hostage to the Devil" in Appendix One: "The Roman Ritual of Exorcism".



Rev Maginot does an *"intense blessing" on the Carolina Street home to expel bad spirits.*

*That same day, Maginot performed a minor exorcism on Ammons. The ritual consisted of prayers, statements and appeals to cast out demons.*

*Two police officers and [Samantha] Ilic, the DCS family case manager, attended the ritual.*

*Ilic said she left believing that something was going on, although she wouldn't go as far as saying it was demonic. She said she got chills during the nearly two-hour rite.*

*"We felt like someone was in the room with you, someone breathing down your neck."*

Finally Bishop Melczeh authorizes Rev Maginot to do a major exorcism (*"same as the minor exorcism but more powerful because it has the backing of the Catholic Church"*).

*Maginot ultimately performed three major exorcisms on Ammons – two in English, and the last one in Latin – in June 2012 at his Merrillville church.*

*[Ammon] said she felt as if something inside her was trying to hold on and inflict pain at the same time. She said it was different from a natural pain but felt as intense as giving birth.*

*In the final exorcism at the end of June 2012, Maginot said he prayed and berated the demons in Latin, rather than English.*

Then Ammon found peace, she had her deliverance from the demons and regained custody of her children in Nov 2012 – 6 months after they had been taken. One greatest testimonies in the story was Ammon giving all the credit and glory to God:

*Ammons said it was not the psychologists who resolved her problems **but God.***

There were different reactions from two persons who witnessed this ordeal. The police captain became a believer however the DCS Samantha Ilic who suffered a series of medical problems beginning a week after her visit to the house (probably from a spirit of infirmity which attached itself to her) - laughed it off and said *"I'm already evil"*.

**1)** *Austin, the Gary police captain, ... told The Star he believed in ghosts and the supernatural but said he didn't believe in demons.*

*Austin said he changed his mind after visiting the Carolina Street house....*

*Austin said simply, **"I am a believer."***

**2)** *Ilic [the DCS family case manager] said she had a string of medical problems after visiting the home. A week after she visited the house for the last time, Ilic said she got **third-degree burns** from a motorcycle. Within 30 days, she also **broke three ribs** Jet Skiing, **broke a hand** when she hit a table, then **broke an ankle** running in flip-flops.*

*"I had friends who wouldn't talk to me because they believed that something had attached itself to me," Ilic said. **Her joking response: "I'm already evil.** They try to find something that's not evil and corrupt it. They wouldn't waste their time on me."*

How did the Ammon & family become demonized? The article doesn't say however in a July 6, 2015 news article writes of a family who are at the beginning stage of their torment where they have called in a demon-slayer to kill the demons and a priest to pray them away. How did their torment begin? By a Ouija board:

*The phantom has also been menacing the couple's three children after it was apparently "summoned" through the use of a Ouija board.*



*The dad-of-three has also asked a vicar to bless his house — but the demon continues to terrorise his helpless family.*

*The ghost has been terrorising the family at their three-bed terraced house in New Tredegar, South Wales, since Halloween last year.*

*Stepson Nicholas Bush, 23, used the ouija board at a separate house — and the ghoul followed him into the Frys' home.*

The stepson used an Ouija board on Halloween and opened a door to himself. He then went to the Fry house and the demon entered that house due to an open door in that family.

This is similar to the spirit of infirmity which attacked Samantha Ilic with broken bones and Officer Austin with his mechanical problems with his equipment.

Demons enters a person by open doors. Father Malachi Martin who was an Catholic (Jesuit) exorcist for 30 years documents the 4 stages a person goes thru to becoming totally controlled by the devil:



General outlines of the process of possessions ran as follows.

**First**, the actual *entry point*, the point at which Evil Spirit enters an individual and a decision, however tenuous, is **made by the victim to allow that entry**.

**Then**, a stage of *erroneous judgments* by the possessed in vital matters, as a direct result of the allowed presence of the possessing spirit and apparently in preparation for the next stage.

**Third**, the *voluntary yielding of control* by the possessed person to a force or presence he clearly feels is alien to himself and as a result of which the possessed loses control of his will, and so of his decisions and his actions.

**Once the third stage is secure**, extended control proceeds and may potentially reach the point of completion – perfect possession.

In any individual case, these four stages will dovetail and overlap differently. And, while the process may be swift, more often it seems to take years to accomplish.

At every new step, and during every moment of possession, **the consent of the victim is necessary, or possession cannot be successful**. The consent may be verbal, but **always involves choice of action**. Once initial consent has been given, its **withdrawal becomes more and more difficult as time goes on**.

It's mentioned in the book that the demons will inflict pain on the person to prevent the oppressed person from attempting to expel them.

One event that happened to our family was four years ago 2 of my wife's friends came to visit. The night prior their airline departure we sat up and discussed many things. The conversation drifted to the bible. Knowing that this woman has interest in history, archeology, science... I brought up the validity of the bible based on science of the bible, history, people & nations listed in the bible. The discussion broke up close to 4 am. The woman went out for a last smoke and came in and while passing me stated that she didn't believe the bible or anything I said.

She in essence denied Jesus. Bad decision. During the discussion she had disclosed that she hears spirits and one follows her around. When they moved to a new house the spirit followed them there. She also mentioned that one of her friends back home sees the spirits.

The woman went into the bathroom to get ready and only had to walk 15 feet to get to the guest room. She made it out of the bathroom when she blacked out. Her arms were at her sides when she fell. She hit the bathroom door then fell face down with her chin striking the concrete floor breaking her jaw in 2 places. The impact forced her teeth together shattering many of her teeth. Bits of teeth and blood were strewn out on the floor. The crashing of her body on the floor was a startling sound but the deep, unnatural groan/moan that came next raised the hairs on all our arms.



*(side note: if you as a male call 911 at 4am reporting a bleeding woman on the ground with loose teeth – expect the sheriff office to send an officer along with the Ambulance and you be questioned for domestic violence.)*

Her jaw had to be wired shut for many months and then teeth fixed. She has never been the same after she denied the bible.

I've wondered: Who caused the black out? She mentioned that she has had a forewarning for all her previous black outs – but not this time. Was it punishment from a demon for questioning her present path or was it from Jesus for her denying the bible after having it be presented to her. I was reminded about Ps3:7 that it is Jesus who shatters teeth of the wicked.

NASB Ps3:7 Arise, O LORD; save me, O my God! For You have smitten all my enemies on the cheek; **You have shattered the teeth of the wicked.**

The bible warns about practicing wicked behavior (Gal5:19-21). If one continues on the wicked road then Jesus will give you over to a debased mind (Rom1:27-32). At that point you may never be able to return (Heb6:4-6).

This is the danger of tolerating a little evil; soon it becomes a habit then a lifestyle then the point of no return. You don't know how much it takes for you to become oppressed so don't experiment. Don't allow your children to participate in Halloween events.

Don't open that door by participating in Halloween. Don't dress up, don't give out candy, don't go to church sanctioned alternative parties (Halloween lite).

If one does dress up & goes trick or treating or partying or engaging in other occult activities then a door could open and your body could experience a home invasion from the demonic realm as the Ammon's family found out. Once your body has an evil spirit then it becomes difficult to find any church willing to help.

**Test: ask your church priest/preacher if they regularly do exorcisms. If they don't or are not learning how to do them then don't expect that church to be able to offer any salvation if you need to expel some unclean spirits.**

You won't be able to run or hide from these attacks and you'll experience torment that the hospital staff will laugh at you, psychologist will call you delusional and the government will call you child abusers and take away your children as what happened to the Ammon family.

Don't give up any ground to the devil. Our fight is real against the evil spirits. They don't sleep and they constantly march forward trying to see if they can cause you to stumble attempting to enter you thru an open door. Fill your house with the Jesus and don't open that door.

**Rom 1:30** slanderers, haters of God, insolent, arrogant, boastful, inventors of evil, disobedient to parents,

**Rom 1:31** without understanding, untrustworthy, unloving, unmerciful;

**Rom 1:32** and although they know the ordinance of God, that **those who practice such things are worthy of death**, they not only do the same, but also give hearty approval to those who practice them.

**Heb 6:4** For in the case of those who have **once been enlightened** and have tasted of the heavenly gift and have been made partakers of the Holy Spirit,

**Heb 6:5** and have tasted the good word of God and the powers of the age to come,

**Heb 6:6** **and then have fallen away**, it is impossible to renew them again to repentance, since they again crucify to themselves the Son of God and put Him to open shame.
